23. TO PRESENT THE QUARTERLY FINANCIAL REPORT -APRIL TO JUNE

2015: The Town Clerk presented the accounts for the last quarter in a new formal to help the Councillors to better understand the status of the income and expenditure. The actual bank balances from the end of the last financial year were recorded along with the bank balance from the current quarter. The Councillors were pleased with the new format but asked the Town Clerk to include the figures for the 2014 quarter as a comparison.  CURRENT ACCOUNT: Give HMRC example t was AGREED to cancel the daily sweep on the current account as there is little interest to be earned. It was also AGREED to retain the

Business Extra account with a nominal balance incase interest rates should rise again and we choose to re-instate the sweep. Following discussions with the bank, it was AGREED to:

- * Increase the bulk payment limit to £35,000
- * Remove the daily sweep on the Current Account
- * Switch most of the funds to the Current Account
- * Retain the Business Extra Account with a nominal balance

- 08. TO REVIEW THE UNAUDITED FINANCIAL STATEMENTS FROM DCK BEAVERS: The statements were not available in time for this meeting. It was AGREED to defer to the Extra Ordinary Meeting the following week.
- 09. TO APPROVE AND SIGN THE ANNUAL RETURN FOR 2014-2015: It was AGREED that, subject to the approval of full Council at the Extra Ordinary Meeting on 15 June 2015, the Finance and General Purposes Committee would approve the Annual Return.
- 10. **TO REVIEW THE FIDELITY INSURANCE**: It was AGREED that with the insurance at £900,000 there was no need this year to increase the sum insured.
- 11. **TO REVIEW AND APPROVE THE ANNUAL RISK REGISTER**: The Register was reviewed and approved.
- 12. TO NOTE THE RENEWAL OF MOTOR INSURANCE FOR ATC FLEET AND ANY REVISIONS: The motor insurance currently stands at £4,043.79 and increase of £395.38. However there were some changes to the policy from last year as we now insure the younger drivers for ATC vehicles. We are currently in a three year deal with Zurich.
- 13, **REQUEST FOR MOTORISED VEHICULAR ACTIVATED SIGN (MVAS) AT THE BOTTOM OF RECTORY HILL**: Cllr Phillips spoke to advise that Bucks County had already looked at the speed on this part of the road and consulted with the police. It was agreed to recommend a reduction down to 40 mph however it was also noted that speed was not always an indicator in the risk of road accidents. It was therefore AGREED not to support the feasibility study for the further reduction of the speed limit on this road.
- 14. **CHILTERN DISTRICT COUNCIL MATTERS**: Congratulations were offered to Cllr Shepherd who has been appointed Deputy Chairman of Chiltern District Council.
- 15. **BUCKS COUNTY COUNCIL MATTERS:** Various highway matters were discussed along with time queries on the double yellow lines for Mill Lane junction.
