113. BUCKINGHAMSHIRE COUNTY COUNCIL MATTERS:

(i) Gore Hill Roundabout - mitigation of HS2 congestion

Cllr Shepherd commented on the recent public exhibition regarding the proposed A355 Beaconsfield relief road. BCC apparently considers that none of the possible revised layouts of the Gore Hill roundabout would alleviate the additional traffic flow from the A355. However BCC remains involved in petitioning High Speed 2 Ltd regarding the impact of HS2's construction traffic at this junction. BCC has therefore decided to remove the junction from the scope for the A355 improvements project, pending the results of the HS2 petitioning. It was agreed that the Clerk would keep in touch with BCC Highways on a regular basis to obtain updates on this situation and will invite a representative from Bucks CC to speak at an ATC planning meeting on the matter.
