Two residents of School Lane addressed Members with their concerns about parking issues on School Lane and asked for the Town Council's support in providing a parking scheme to resolve the problem. The residents were informed that parking is

within the jurisdiction of the County Council rather than the Town Council and the Clerk reported that Bucks CC had already been approached by residents of School Lane and had been informed that the Highways Department would be providing a costing for a specification in the Autumn for possible inclusion in the 2018/19 LAF Budget, but any project agreed by LAF would require matched funding. It was also suggested that the residents contact Bucks County Councillor Isobel Darby for support.

49. BUCKINGHAMSHIRE COUNTY COUNCIL MATTERS:

i) Local Area Forum (LAF) Funding

It was reported that the LAF has agreed to part fund a Phase 1 Parking Review during 2017/2018 on roads in Amersham to the south of the railway line, providing they receive matched funding. (It is expected that further phases for other areas of Amersham would follow in 2018/19 and 2019/20). It was confirmed that no action would be taken by the County Council in addressing parking problems without matched funding being provided by the Town Council. After discussion

AGREED to

Provide matched funding for the Amersham Parking Phase One project at a cost of £5,794 to the Town Council, providing a holistic approach is taken to addressing parking problems in the whole of Amersham, as well as Chesham Bois. It was suggested that any further matched funding from the Town Council for parking reviews in Amersham would need to be separately precepted.

ii) Resident's complaint about parking problem on Station Road

The Clerk reported on a resident's complaint about parked vehicles causing a visibility hazard for vehicles egressing the driveway of Amersham Court on Station Road. As this would appear to be a highways safety issue, the Clerk was asked to refer this back to the Highways Department at Bucks County Council.
