i) Funded Pilot Scheme for pot hole repair on minor roads

A preliminary report from Mark Richardson was circulated prior to the meeting with information about a proposed pilot scheme for Amersham Town Council to undertake pot-hole repairs on minor roads in Amersham on behalf of Bucks County Council. It was noted that the full business case report will be prepared for consideration at the Finance Meeting on 13 August 2018.

ii) Bucks CC Parking Meters on King George V Road

Councillor Morgan reported that, (as expected by Town Councillors), the parking meter bays installed by Bucks CC on King George V Road which came into force in early July, are generally not used by drivers and have caused displacement of parked vehicles onto adjacent roads, particularly Orchard Lane. It is understood residents are

now planning a petition to Bucks CC requesting the problem be addressed, as parked vehicles on Orchard Lane are proving a hazard to traffic.
