## 47. CHILTERN DISTRICT COUNCIL MATTERS:

# a) Chiltern Lifestyle Centre

Councillor Shepherd reported that the public exhibitions for the new centre had been well received, though adequate parking provision appears to be the issue of greatest public concern. It was suggested that Chiltern District Council considers providing better signage for pedestrians between the new multi-storey car park at the station and the leisure centre. Members would also like clarification on the name of the new centre. Councillor R Jones offered to raise these concerns at the CDC Working Group meeting.

### 48. **BUCKS COUNTY COUNCIL MATTERS:**

#### i) Funded Pilot Scheme for pot hole repair on minor roads

A report from Mark Richardson had been circulated prior to the meeting. Concerns were raised about the proposals. After discussion it was agreed to defer a decision until the Council meeting on 26 November when a Bucks CC Councillor will be present to answer questions. In the meantime, the Clerk was asked to obtain additional information from Bucks CC on their objective and business case for the proposals.

### 49. **MATTERS FOR REPORT:**

The Clerk informed Councillors of the Bucks CC public consultation on proposed cost-saving measures for the county's household recycling centres. These include closing one (or possibly two) recycling centres, likely to be Bledlow and Burnham, as well as restricting opening times at other sites and introducing a charging scheme for some types of waste. Responses can be submitted via the Bucks CC website.
