#### 40. Amersham in Bloom Items

### (i) Amersham in Bloom Update

The report circulated prior to the meeting detailed the Amersham in Bloom highlights over the past month. The report noted the following:

- 16,000 spring flowering bulbs have been planted throughout Amersham this autumn, in association
  with school pupils and bloom volunteers. The town's flowerbeds have all been refreshed with
  winter/spring plants.
- Over the past three months £750 has been raised through the sale of Amersham in Bloom greeting cards
- The community orchard, funded in the main, through the Tesco 'Bags for Help' initiative is due to be planted on 13 December. The fruit trees have been sponsored by Rotarians and bloom volunteers, enabling the grant from Tesco to pay for wildflower/grass seed, tree labels and cages.
- Amersham in Bloom supported the Rotary Club's 'eradicate polio' campaign, working in partnership with the group and schools, to plant 5000 crocus corms.

# (ii) Approval of the 2019 Memorial Gardens Display

The report circulated prior to the meeting outlined a proposal to create a Wildlife and Conservation display in the Memorial Gardens in 2019. Following discussion, the Committee commented that the display entitled *Conservation in Bloom,* is both innovative and original while embracing the Mayor's environmental theme. The committee agreed to **approve** the aforementioned proposal which would come to life within the central border of the Memorial Gardens (on the bed where the biplanes are located).

The Mayor commented that the WW1 Commemorative Display had been a huge success this year, perhaps creating a benchmark that may never be exceeded. In addition, the committee **agreed** that lone soldier should remain in the Memorial Gardens as long as it is deemed possible.
