57. APPROVAL OF THE GRANTS COMMITTEE'S RECOMMENDATIONS:

RESOLVED that the Grants Sub-Committee's proposals be accepted. It was suggested that the Clerk requests additional information from Plant Based 4 Good in relation to their application, in order for Council to consider allocating them a grant. In the event that a grant is not awarded to them, it was agreed that the balance of the grant fund would be carried forward until the 2022/23 financial year.

58. APPROVAL OF CARBON AUDIT FOR COUNCIL PROPERTIES:

The three quotations obtained by the Town Clerk for a carbon audit of ATC properties were considered. After discussion, it was AGREED that the Clerk would seek revised quotations, with the omission of any council buildings leased to 3rd parties. The Clerk would also investigate the possibility of the council providing some of the data related to the building surveys, in order to reduce costs. It was agreed that the Climate Action Working Group would review the revised quotations and report back to full Council at the January meeting.
