60. <u>UPDATE ON OLD AMERSHAM CHRISTMAS EVENT:</u>

Councillor Roberts and Councillor Flys reported that they had discussed arrangements for the Old Amersham Christmas event with the lead organiser Drew Burnett and it was agreed that the Council would underwrite the cost of the vintage fairground up to £5,000, with the proviso that sponsorship would be sought for this cost. It is anticipated that the council's likely contribution would be £1,000 to £2,000, (net after sponsorship income). Steve Catanach reported that the Council had also been asked if it would temporarily hold any sponsorship income in its bank account until the organisers have set up a new account.
