### 41. TOWN COUNCIL BUDGET FOR 2024/25 AND PRECEPT REQEUST:

The Budget Papers had been circulated prior to the meeting. The Clerk also reported that Buckinghamshire Council had confirmed the tax base figure for 2025/26 and Councillors expressed surprise that for the second consecutive year, there was no change in the tax base. The Clerk was instructed to contact Buckinghamshire Council to find out how the parish tax base figures are calculated. Options were considered on how best to minimize the precept increase for 2025/26, in order to lessen the burden on Amersham council tax payers. After discussion

Proposed – Councillor M Roberts Seconded – Councillor E Shepherd

It was

RECOMMENDED to propose an increase of 4.80%. This figure would be achieved by lowering the capital fund allocation from £70,000 (as recommended by officers) to £40,000 and using the councils reserves to finance some of the planned capital projects and to allocate the projected surplus for 2024/25 to capital funds. The budget and precept for 2025/26 will be agreed at the Council meeting on 20 January 2025, with the provisional figures as follows:

Total Precept for 2025/26: £1,079,277
Band D equivalent (£/annum) £154.68
Percentage increase from 2024/25: 4.80%

### 42. MATTERS FOR REPORT:

- i) The Clerk reported on an on-going parking issue on land owned by Amersham Town Council on Station Road
- ii) Members noted a report on an issue in the Market Hall building
- iii) The Clerk reported on a new consultation from Buckinghamshire Council on 'lane rental', where Bucks Council intends to charge a daily rate for road closures. The matter will be discussed at the next Council meeting.
